## DECLARATION

1. I/We hereby declare that I/We desire to have and agree with TISCO, to take supply of energy for the above mentioned purpose and to be bounded by the Rule no. 45, 56, 79, 82, 83 & 138 of the schedule to the Indian Electricity Rule, 1956.
2. I/We agree to pay the fees and charges in force from time to time and to abide by the conditions of power supply by the Tisco Ltd., Jamshedpur.
3. I/We further hereby agree at any time after the supply of energy has been commenced, increase the no, of or points of light, fan or meter etc. of premises or in any way after the position of wiring therein, notice must be sent in writing to the Tisco Ltd. whose representative will call and inspect the alteration and if necessary, change the meter, fuses and alter the service line. Failure to give such notice may derange the supply system and render the supply liable to be disconnected. During such time of alteration addition of repairs being executed, the supply to the circuit which is being altered, added or repaired, must be entirely disconnected and it shall remain disconnected until the alteration, addition or repairs have been passed by the Steel Co.
4. If any electrical appliances which is likely to affect injuriously supply to the consumers or uses the energy supplied or deals with it in any manner so as unduly or improperly to interfere with the efficient supply of energy, to any other person by Tisco, or fail to keep in proper order any meter belonging to him by which the supply is registered, the Tisco, may discontinue the supply so long as such appliance is so adopted or energy is so used or dealt with or the meter is not kept in proper order as the case may be.
5. No direct on line starting Electrical appliances of 440 volts, 5 kw & above.
6. The estimated amount will be paid within 3 months from the date of estimate made failing which the approval will be treated as cancelled.
